Terry Rose Timber Sale Notice

Bid Opening: Friday February 28, 2014 at 10:00 AM CDT

Note: Ms. Rose & Ms. Carlton are sisters. Access to either tract can be used through the other ones property for timber removal. (See maps for tract locations)

Terry Rose has authorized Arbor Springs Forestry to serve as her agent in the sale of said hardwood timber located on her property near McEwen in Humphreys County, TN. The property is identified as Control Map 100 Parcel 007.11.

General Description of Sale:

This is a partial clearcut and partial marked sale of hardwood sawtimber and pulpwood on a tract consisting of 93.74 acres. The actual sale unit includes 66.78 acres. (48.55 acre clearcut) and (18.23 acre of "blue marked" timber) which contains 155,559 bdf of hardwood sawtimber, and 1544 tons of hardwood pulp/topwood. All hardwood sawtimber trees average 75 bdf/tree. There are 10 White oak trees with an estimated 1350 bdf of potential Veneer and 65 White oak tree with an estimated 4782 bdf of potential Stave. The estimated Veneer/Stave is pulled out of the total volumes for each species. White oak makes up 55% of the total volume, followed by Red oak (30 %).

The tract has good access off of TN City Road and would serve as a good winter time job.

Location:

The sale unit is located at the intersection of Martin Branch Rd, TN City Rd., and Humphreys County Line Rd. near the Humphreys/Dickson County Line. The proposed decking area is near the northeast corner of the tract just off of TN City Rd. Access from I-40 Exit 163: From the exit travel North on HWY 48 for 0.5 miles. Turns left onto Harris Rd. and travel 1.6 miles. Turn Right onto Garners Creek Rd. and travel 1.1 miles. Turn left onto Potter Rd. and travel 0.3 miles. Hang to the right onto Humphreys County Line Rd. and travel 1.7 miles. The tract will be located to the south of the intersection. The best way to walk and view the timber is to park at the northeast corner of the property and access the old logging road. There is PINK flagging at this corner off of TN City Rd.

Sale Description:

The sale includes the area as shown on the attached map. 18.23 acres is designated as "marked" timber and 48.55 acres is designated as clearcut. Within the marked timber sale unit only those trees marked

with PINK PAINT at dbh and below stump level are eligible for harvest. All sawtimber trees are marked with a horizontal "SLASH", pulpwood trees are marked with a "DOT", and trees marked with a "SLASH/DOT" represent a deduction in volume estimate. Within the clearcut sale unit all trees are eligible for harvest. All trees within the clearcut sale unit must be felled. Any merchantable products can be removed at the option of the buyers. All property lines are well marked with PINK FLAGGING. The marked timber areas are the drainages on the tract and are well flagged with BLUE FLAGGING. All BMP'S must be applied throughout the sale unit. With the exception of the decking area there will be a 75 foot visual buffer left along the county road on the north end of the sale unit.

Bidders are welcome to look at the timber at your convenience. I would also be happy to meet with you on an appointment basis to show you the timber. Please call Mrs. Rose at 615-218-0275 before coming on the property to view the timber. If she does not answer leave a message.

Terms of Sale:

BID OPENING: Sealed bids on a submitted lump sum basis only will be accepted until 10:00 AM CDT on Friday February 28, 2014 at which time they will be opened. The bid opening will be held at Donna's Place in Burns, TN (Across from the Dollar General Store). Buyers are welcome to attend the bid opening. Bids may also be submitted by mail, fax, phone or email on the attached or similar Bid Offer Form, but must be received no later than 8:00 AM on February 28, 2014. (Morning of the bid opening). Please call if sending a fax to ensure it was received.

PREFORMANCE BOND: The Successful Bidder shall furnish the Seller's Agent with a Performance Bond in the form of a check in the amount of \$1,500.00. This will be due at contract signing.

PAYMENT: 100 % of payment for said timber is due at contract signing by March 14, 2014

Notes:

- The attached volumes are estimates only. Bidders should satisfy themselves as to the quality and quantity of the said timber.
- 203 individual sawtimber trees are marked within "pink" paint.
- Acreage was determined with handheld GPS unit. Clearcut unit volumes were determined with 10 BAF prism plots at 1 plot/acre.

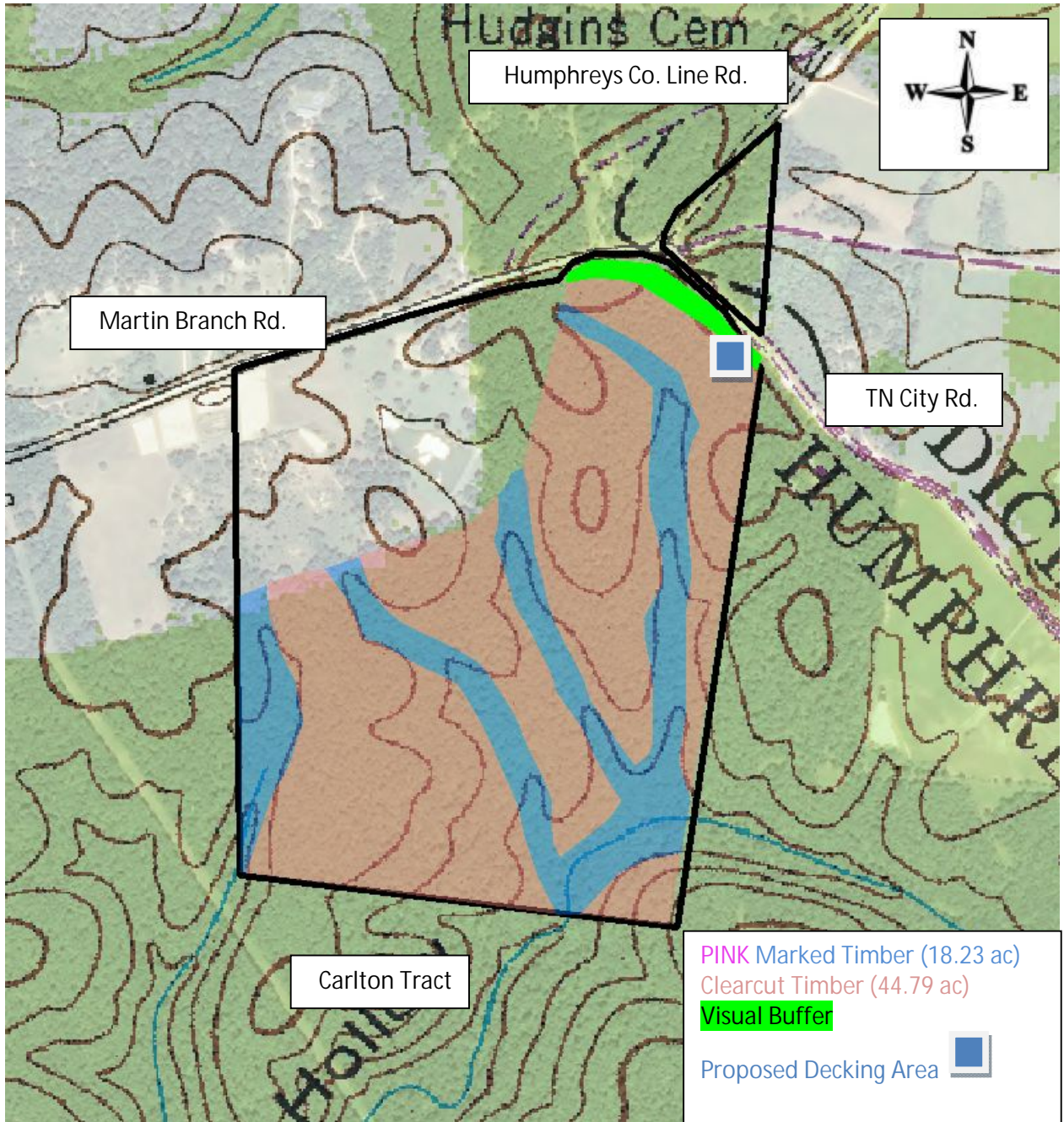

TERMS AND CONDITIONS OF SALE

1. The Purchaser agrees to make payment to the Seller at contract signing.
2. The Purchaser shall furnish the Seller's Agent with a Performance Bond in the form of a check in the amount of \$1,500.00.
3. This Agreement shall be in full force and effect for a period of 12 MONTHS (1 year). Should restoration work or timber removal not be completed prior to contract expiration due to inclement weather conditions, the Purchaser shall be granted an additional period for such restoration equal to the time of the suspension.
4. The Seller guarantees title to said timber and agrees to defend it against any and all claims whatsoever.
5. Notice of the intention of the Purchaser to begin removal of said timber shall be given to the Seller and the Seller's Agent, Arbor Springs Forestry, 333 Beechwood Drive, Burns, TN 37029, Phone: (615) 498-8700, at least 48 hours before any logging activity begins. A "PreHarvest" meeting will take place on premises before any said timber is removed.
6. Upon completion of all logging operations or as soon thereafter as conditions permit, the Purchaser shall smooth ruts, created by the Purchaser, out of all existing and newly created skid and truck roads, and the log landing(s) must be cleared of all debris related to the logging operation, smoothed and seeded if necessary. The purchaser agrees to install water diversion in accordance with Tennessee "Best Management Practices" suggestions to prevent erosion and water quality issues.
7. The Seller agrees to allow the Purchaser, his agents or employees, to enter upon said premises, for the purpose of removing the designated timber there from, and do such other things as may be necessary in connection with the operation, including the right and privilege of the Purchaser to use sufficient and necessary space in and upon said premises to handle, load, and haul all timber covered by this Agreement, and no other.
8. Only trees under the terms of this Agreement shall be cut. Trees not designated for sale under this agreement shall be protected against unnecessary injury. No cut, broken, or uprooted trees shall be left hanging in standing trees. All trees cut shall be felled onto the premises of the Seller; any tree felled over the property line of the premises shall be brought back onto the premises immediately, and any damage that such activity creates shall also be repaired immediately. Within the clearcut sale units all trees must be cut. All logging debris must be left in a manner that site can be replanted.
- 9.. The Purchaser shall remove all materials brought onto the premises prior to the expiration of the term of this Agreement and shall remove on a daily basis any papers, bottles, cans, and materials which may cause an unsafe, unsanitary or unsightly conditions.
10. Before entry onto the premises to conduct operations under this Agreement, the Purchaser shall provide the Seller's Agent with Certificates of Insurance showing general liability insurance with a single limit of liability no less than One Million Dollars (1,000,000.00) as well as Worker's Compensation Insurance as required under the laws of the State of TN. The Purchaser shall not conduct any further operations during the term of this Agreement upon the premises after the expiration of insurance as shown by the certificate provided to the Seller's Agent until the Purchaser provides the Seller's Agent with such additional certificates evidencing the renewal or replacement of such insurance to fulfill the requirement of this paragraph.
11. This Agreement shall not be assigned by the Purchaser without the written consent of the Seller. Purchaser shall have the right to use contract loggers for harvest operations.
12. The Purchaser shall indemnify and save the Seller and the Seller's Agent harmless from and against

any and all claims for damages to property, or injury to, death of, any person, including employees of the Purchaser, of any action arising out of the actions of the Purchaser.
